

Dog Control Fees

1 July 2019 to 30 June 2020

Definitions

Dog to be registered Any dog over the age of 3 months. Failure to do so will result in an infringement notice being issued and a fine of \$300.00.

Registration period The period 1 July in any year to 30 June the following year.

Working dog For the full definition, refer to section 4(3) of the Dog Control Amendment Act 2006

- Any disability assist dog
- Any dog used by the Police or any constable, Customs Department, Ministry of Agriculture, Ministry of Fisheries, Ministry of Defence, Department of Conservation, Department of Corrections, Aviation Security Service, Civil Defence Emergency Management, security guards
- Any dog kept for the purpose of destroying pests in accordance with the Biosecurity Act 1993 (proof of this must be provided at time of registration)
- Any dog kept solely or principally for the purpose of herding or driving stock

| Working dog (WD) | \$43.00 | \$65.00 |
| Working dog (WD) - More than 5 dogs | \$215.00 | \$65.00 (lose capped discount) |
| Good Dog Owner (GN or GY) | \$62.00 | \$133.00/198.00* |
| Non-working dog entire (NWN) | \$132.00 | \$198.00 |
| Non-working dog de-sexed (NWY) | \$89.00 | \$133.00 |
| Dangerous dog entire (DNN) | \$330.00 | \$495.00 |
| Dangerous dog dex-sexed(DNY) | \$222.50 | \$332.50 |

**You will lose your Good Dog Owner (GDO) status if you do not pay the registration fees before 31 July. You can reapply the following year.*

For a dog at the age of 3 months that is due to be registered part way through the current registration year, the owner shall pay a pro-rata registration fee according to how many months remain in the registration year.
