**RESERVED DECISION OF THE RANGITIKEI DISTRICT LICENSING  
COMMITTEE**

**1. Application**

**Abhishek Kalra** made the application on the prescribed form received on 7 December 2018. The applicant intends using the certificate at 'Le Café Telephonique', Taihape, which holds an on licence. The applicant has limited experience working at licensed premises therefore the inspector recommends an 'undertaking' is placed on the certificate..

The application included the applicant's qualifications and three letters of reference attesting to the applicant's skills and suitability to hold a certificate.

The applicant has attained the relevant License Controller Qualification and has not incurred any convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *(a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*

- *(d)any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e)any matters dealt with in any report made under [section 220](#).*

### 3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition noted within report received 12 December 2018.

**3.2 Licensing Inspector** – Full report assessing **Abhishek Kalra**’s credentials against the Acts criteria. The inspector has interviewed the applicant and is satisfied that the applicant has the necessary knowledge to hold the certificate.

The inspector concludes that the application is supported with an undertaking.

### 4 Conclusion

Based on the evidence provided to me within the application and statutory reports I conclude that **Abhishek Kalra** meets the criteria to be granted a Managers Certificate.

### 5 Decision

Accordingly the application for manager’s certificate is **Approved** for issue for a period of one year provided the applicant sign an undertaking to only use the certificate at ‘Le Café Telephonique’, Taihape, and this be tagged on the certificate.
