**RESERVED DECISION OF THE RANGITIKEI DISTRICT LICENSING  
COMMITTEE**

**1. Application**

**Jasleen Saluja** made the application on the prescribed form received on 14 December 2018. The applicant intends using the certificate at 'Club Hotel and Captain Cooks Bar' Marton which they part own and has an on-licence. The applicant has over 6 months experience working at these licensed premise.

The application included the applicant's qualifications and three letters of reference attesting to the applicant's skills and suitability to hold a certificate.

The applicant has attained the relevant License Controller Qualification and has not incurred any convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *(a) the applicant's suitability to be a manager:*

- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*

- *(d)any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e)any matters dealt with in any report made under [section 220](#).*

### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition noted within report received 27 December 2018.

**3.2 Licensing Inspector** – Full report assessing **Jasleen Saluja's** credentials against the Acts criteria. The inspector has interviewed the applicant and is satisfied that the applicant has the necessary knowledge to hold the certificate.

The inspector concludes that the application is supported.

### **4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Jasleen Saluja's** meets the criteria to be granted a Managers Certificate.

### **5 Decision**

Accordingly the application for manager's certificate is **Approved** for issue for a period of one year.
