Local Government Official Information Request

Thank you for your request for information from Council. All requests to the Council for information are required to be considered in accordance with the Local Government Official Information and Meetings Act 1987 (LGOIMA). Your request for information was received 11 April 2023 and related to Council offices, Stationery and Working from home. Our response is below:

1. Does your council provide office space to a Union?

Response:

No, however the Public Service Association (PSA) have in the past hired Council public facilities.

2. If yes, which Union is it and do they pay for the office space?

Response:

3. If yes, how much does the Union pay for the office space? If no, what is the rental value of the office space given to the Union?

Response:

The one time the PSA hired the Kokako Street Pavilion in Taihape there were charged in line with Council's Fees and Charges Schedule – page 8 on our website: <u>Schedule of Fees and Charges 2022-23 - approved for consultation (rangitikei.govt.nz)</u>

4. Please provide us with your council's current working from home policy

Response:

5. How much does the council pay to rent its offices?

Response:

Council owns all its on offices.

6. What is the current staffing occupancy level of your offices? This relates to working from home versus staff in the office.

Response:

99% of staff work from RDC offices, 1% work from home.

7. How much has the council spent on printing and stationary in the last 12 months? Please provide a breakdown of costs.

Response:

In the 2021/22 financial year a total of \$47,298 was spent on printing and stationery – we do not track these costs separately. If a detailed breakdown is required this will require extra work and may incur a charge to provide this. Please let us know if you want us to go ahead with this work and we will provide an estimate of time and cost to provide this.

8. How much does the council spend on newspaper and magazine subscriptions? Please provide a breakdown of costs.

Response:

In the 2021/22 financial year a total of \$18,125 was spent on newspaper and magazine subscriptions, this includes publications at our libraries – we do not track these costs separately. If a detailed breakdown is required this will require extra work and may incur a charge to provide this. Please let us know if you want us to go ahead with this work and we will provide an estimate of time and cost to provide this.
