



## PUBLIC NOTICE OF SUBMISSIONS ON NOTIFIED PROPOSED PLAN CHANGE 3

### Clause 7 of Schedule 1 of the Resource Management Act 1991

Rangitikei District Council (Council) publicly notified **Proposed Plan Change 3 – Urban Growth** on 12 March 2026.

Council is now notifying the availability of a summary of decisions requested by persons that made submissions on Proposed Plan Change 3.

### Who can make a further submission?

In accordance with Schedule 1, Clause 8(1) only the following persons may make a further submission, in the prescribed form, on Proposed Plan Change 3:

- any person representing a relevant aspect of the public interest; and
- any person that has an interest in the proposed plan change greater than the interest that the general public has; and
- the local authority itself.

The further submission must be in Form 6 of the Resource Management (Forms, Fees and Procedure) Regulations 2003.

A further submission must be limited to a matter in support of, or in opposition to, a relevant submission made under clause 6 to the proposed plan change.

**Further submissions must be submitted no later than 10 working days after the day on which this public notice is given, which means the last day for making a further submission is Friday, 12 June 2026.**

### Service of further submissions:

In accordance with Schedule 1, Clause 8A(1) a person who makes a further submission must serve a copy of it on:

- Rangitikei District Council; and
- the person who made the submission under Clause 6 to which the further submission relates.

The further submission must be served on the person referred to in subclause (1)(b) no later than 5 working days after the day on which the person provides Council with the further submission.
