Mayor's Desk

he new year is upon us. I trust you all enjoyed a relaxed and restful Christmas break with family and friends.

The work that we are concentrating most on at Council at the moment is the significant contract we have with our community - the Long Term Plan or LTP. This will take up most of our time

between now and June. This is where we set our aspirations and aims in the vision of Council, work out the work programme and the budget that's required to drive it. The Long Term Plan is a 10 year document that is reviewed every three years. The challenges in the LTP are vast. On the positive side our district is changing dramatically. We are getting industry wanting to come here, we have hundreds of new houses going in and the much needed increase in population will make the rates affordable in the future. In the short term there comes some , pain with this in terms of making sure that the infrastructure needs to support the new communities of people are up to speed.

There will be an extensive public consultation month during mid-March to mid-April with many community meetings scheduled for myself, Councillors and Executive Team members to join, to talk to you all about your concerns and seek your input into that document.

There are a number of other significant contracts that we have. This year we will see the Mangaweka Bridge being replaced. This is a major project that is funded both by Manawatū District Council and Rangitikei District Council together with the NZ Government through Waka Kotahi (the old NZTA or Transit). We will use the public consultation process going around the district to engage with people over the future of setting up a Trust for the retention of the old bridge, the only cantilever road bridge left in New Zealand.

Other contracts will see the Putorino Landfill being remediated which involves digging out all the old historic rubbish and reforming the riverbank. This is not a problem unique to our district but to me it is a sign of things to come for New Zealand.

This year will also see the construction of the new amenity block on Taihape's Memorial Park. I understand the need for the wide public consultation that has occurred but it will be fantastic to finally have a decision and get a facility that will enable sport to continue on the park.

Everyone in Marton has been watching the development of the new playground at Memorial Park and our thanks go to Lucy Skou and Brenna O'Neill and the Committee that have made this possible. We have other groups throughout the district that are interested in doing similar projects, groups in Taihape looking to upgrade the playground there, we have a group working on the Papakai Park Memorial Park Walkways and we have groups looking at Wilson Park in Marton and the Ratana Playground. As a Council we need to support these groups in their desires and commitment to improve our communities for sport and recreation.

Dog Safety Education

Papakai Park Update

On 2 November 2020, Rangitīkei District Council (RDC) met at Papakai Park with representatives of the Friends of Taihape Society to discuss possible future solutions for the wastewater overflow structure in the park.

An agreement was made to fill the existing overflow hole in the park. The hole was then backfilled and re-seeded in mid-January 2021. The boulders were repositioned along the gravel drive/carpark area to restrict vehicular access to the grassed area.

The existing overflow pond was to be moved towards the embankment just south of the new overflow tanks, however this location was found to interfere with existing storm water management. A new storm water solution will be designed and installed to accommodate this difficulty. The design will have a suitable slope to allow mowing of the area inside the pond, and will be grassed and usable during times of no overflow. Construction will start soon, we will keep you up to date as the work progresses.

Putorino Landfill

On Monday 18 January 2021 our contractor, Central Demolition, began establishing their worksite for remediation of Putorino Landfill.



The first three weeks of work will involve moving their plant and equipment to site, installing site offices, erecting fencing and implementing other safety precautions.


Once the resource consent applications are approved, sheet piling will be installed to protect the river and cliff face while the landfill material is excavated, tested, sorted and transported for disposal. We are expecting the resource consents to be granted on 9 February 2021. The remediation is expected to be completed at the end of April 2021.
