



Working on the Timeline - Bulls Community Centre

Now that we have a realistic budget in place for the Bulls Community Centre, it is time to address the timeline that will take us through to the completion of the Centre.

Construction was halted for the duration of the COVID-19 Level 3 and 4 lockdown. This situation affected infrastructure and building construction across the whole country. And of course, no one can be blamed for this. The lockdown meant an automatic six week delay for the project.

But with the lifting of level 3 lockdown, limited construction was able to resume. And while workers were back on site they were operating under a raft of restrictions that meant the rate of construction was much slower than normal.

The basic social distancing rules under level 2 meant workers had to make sure they kept a metre space between each other; and hand and equipment sanitising was also necessary. These arrangements stayed in place until alert level 1, which meant work under the previous levels didn't flow as smoothly or as speedily as it usually would.

Other work however continued during the lockdown period. Firstly, an interior designer has been employed to take charge of all things interior – from colours to curtains to signs. This will result in a cohesive and consistent look and feel for the Centre.

Secondly, a Cultural Designer has been engaged. They will help us to bring to the Community Centre a design and decor that reflects the inclusive and multicultural nature of Bulls and the Rangitikei District.

Finally work continued designing a bus lane to the rear of the building and a town square to the front, for future Council consideration.

So with these time considerations in mind, Council is planning for the construction of the Bulls Community Centre to be completed by the end of July 2020. There will be a period after that for 'fit-out and moving in' and a public/community opening will be planned for September.

Council agrees with payments to suppliers being accelerated

At the Council meeting on Thursday, 30 April Councillors agreed to a number of initiatives to assist businesses in response to COVID-19, one of these was the proposal to accelerate payments made to businesses by paying them weekly, rather than the 20th of the month following the receipt of an invoice.

This direction was reinforced recently by Crown Ministers in a letter to all Councils. In responding to this letter Mayor Andy Watson said that "he was pleased our Council was able to put this in place for those that do business with us. COVID-19 has had a big impact on small to medium businesses and this assistance with cash-flow is a small gesture we can make. I support and encourage this approach being suggested to all Councils across New Zealand. We can help lead the way to unlocking cash-flow to protect jobs and support ongoing business sustainability."

Are you eligible for a Rate Rebate?

A rates rebate is a partial refund for people who pay rates to the council.

If you are the person paying rates for the home you are living in, you could get up to \$640 off your rates bill.

Once you receive your rates bill, you can apply for a rates rebate for 2019/20.

If you have received a rebate previously you will automatically be sent an application form from us.

If you have not applied/received a rebate in the last rating year, phone our Customer Service Staff on 0800 422 522 and will send an application to you.

Applications are due by 30 June 2020.
