#### 15 Intermediaries

From time to time, an individual resident or business is dissatisfied with how Council has addressed an issue which they have raised, even though Council considers that the actions taken are reasonable and fair. While such people have a right to request the Ombudsman to investigate the matter, that may be seen as evading the issue and will certainly take time.

An alternative mechanism is to invite the chairs of the Community Boards and Community Committees to act as intermediaries. Such people are more distant from Council than the Mayor and Councillors which means governance-management boundaries are less of an issue. Their role would be to listen to both sides of the story and convey their view. It would not be binding, but it could help increase mutual understanding by both parties.

At its 25 June 2020 meeting, Council endorsed this principle, and invite Chairs of each Community Board and Community Committee to be intermediaries to assess whether Council has been reasonable in fair in responding to a particular issue from a resident or business within the District, and (if the chairs agree) setting that within a broader complaints policy to be considered by the Policy/Planning Committee.

#### We've approved FALLEN SOLDIERS' MEMORIAL for entry on the New Zealand Heritage List

Since we were last in contact with you, our Board has carefully considered whether to enter Fallen Soldiers' Memorial, 1 Daniell Street and High Street (State Highway 1), Bulls (List no. 1183) on the New Zealand Heritage List/Rārangi Kōrero ('the List').

After looking at the proposal report our Board has decided that the Bulls Fallen Soldiers' Memorial has sufficient significance to be entered on the List as a Category 2 Historic Place.

The List entry will take effect on 11 March 2020. We've enclosed a printout of the List entry and the final report for your information.

#### We didn't seek public submissions about this property

As you are aware, we've made our decision in agreement with Rangitieki District Council as the owner of the property (and any other relevant registered interests included on the property's Record of Title). Because the owner has given their written approval for the List entry, the law doesn't require us to seek submissions from the public.

We'll place a public notice about the Board's decision in the Manawatu Standard on 7 March 2020 and on our website, www.heritage.org.nz.

#### You must note this List entry on building consents, PIMS, and LIMs

Once the List entry takes effect, on 11 March 2020, as the Local Authority you must note it on all:

- building consents
- **Project Information Memorandums**
- Land Information Memorandums.

These notifications are required by law (see section 14 of the Building Amendment Act 2009 and section 44A of the Local Government Official Information and Meetings Act 1987).

#### If you're selling to an overseas buyer

If it is ever planned to sell the property to an overseas buyer, the Overseas Investment Office may consider the property's heritage values when deciding if the property is 'sensitive land' under the Overseas Investment Act 2005. #### Our recommendation for this property

Properties on the List should be conserved for the future. Summary: The Fallen Soldiers' Memorial in Bulls, completed in 1921, sits prominently in

the Bulls streetscape. It is historically and socially important as an evocative testament to the impact that the First World War had on this small rural service

town.

From the outset of the war, especially with the losses at Gallipoli, the deaths hit Bulls hard. The small district recorded at least 44 dead over the course of the war, with the cost to New Zealand reaching over 16,000 dead, or nearly seventeen percent of those who served. Additionally, forty percent of the returned service personnel bore the scars of injury or illness, meaning the consequence of the First World War profoundly changed New Zealand. The Bulls Fallen Soldiers' Memorial has historic and social significance because, like most other communities in New Zealand, Bulls sought to grieve for, honour and remember the sacrifices of the fallen, first through a ready adoption of Anzac Day, and then later through commemorating the dead via a permanent monument.

The Bulls Fallen Soldiers' Memorial is part of a group of over 500 First World War memorials, creating New Zealand's largest commemorative landscape. It is typical of its type, the obelisk being the most common memorial form. The symbolism etched on the granite speaks of the struggle to grieve and make sense of war losses, alongside a desire to be patriotic and committed to Empire. Pride in New Zealand's individual contribution to the world war reflected the beginnings of a sense of national identity.

Successive generations of people from Bulls and the wider district have continued to use the memorial as a focus for their honouring of war service on Anzac Day. In later years there is an acknowledgment of a sense of national identity that this commemoration serves, with the World War One centenary events (WW100), incorporating the memorial, the latest illustration of this. The central location readily enables public solemn reflection on the effect the war had on this rural area.

By the end of the First World War over 16,000 New Zealanders had lost their lives. The construction of war memorials in the post-war years served to provide a physical space for the focus of commemorative Anzac Day rituals, thus giving individuals and communities a place to grieve and remember. The Bulls Fallen Soldiers' Memorial, a modest but representative example of a First World War memorial, reflects the historic importance local communities around the country placed on acknowledging their losses in a public way. The memorial has historic significance because it represents local sentiments of pride in sacrifice of the local men, patriotism and commitment to Empire, as well as memorialising in stone the names of the fallen. These sentiments persisted, as reflected by the addition of those lost during the Second World War and the structure's continued central role in local Anzac Day commemorations.

Aesthetic Significance or Value

The Bulls Fallen Soldiers' Memorial has aesthetic significance as a prominent marker in the townscape. Located at a crossroads on the main highway through Bulls, the memorial and the surrounding area are a well curated commemorative space befitting the solemn nature of its purpose. Like other war memorials, the commemorative inscriptions and symbolism carved into the stone lend gravitas to the space, readily imparting a sense of loss and sacrifice to the public.

#### Social Significance or Value

The Bulls Fallen Soldiers' Memorial has been an important part of the townscape since its construction in the early 1920s. Since then, the memorial has been the focus for Anzac Day commemorations - a site where people from the Bulls and the wider district come to remember the war dead and honour the service of returned soldiers. Maintenance of place has been ongoing over the years, sustained community esteem shown by use of the place connection with the First World War centenary commemorations.

a) The extent to which the place reflects important or representative aspects of New Zealand history

First World War memorials are important landmarks in towns across New Zealand, symbolic of the significant impact that the war had on communities. and the nation. The war stimulated the creation of an extensive commemorative landscape of war memorials that was without parallel in the history of New Zealand. These post-First World War memorials became significant public spaces in most towns, such as in Bulls, becoming the focus for commemorating the sacrifice of fallen soldiers and the service of returned personnel. Unlike the unabashed imperialistic overtones of South African War memorials, the symbolism and inscription on First World War memorials are often ambivalent. This is indicative of the struggle for meaning that confronted bereaved communities in light of the extent of the loss of life in the war. Sorrow and remembrance are often juxtaposed alongside other societal attitudes of the day are such as pride in the war service. New Zealand's place in the Empire, and the prominence of militarism in society. The Bulls monument further reflects social mores of the time via the links forged between Flock House and Bulls. Flock House (List no. 7576) was established by New Zealand's pastoral elite as a prominent symbol of New Zealand's connection to the Empire post First World War, with the pupils from the school being to the fore in Anzac Day proceedings in Bulls. The links were such that former pupils who died in the Second World War were commemorated on the Bulls Fallen Soldiers' Memorial.

- (e) The community association with, or public esteem for the place The community connection to the Bulls Fallen Soldiers' Memorial was evident at the outset, with its construction the result of community fundraising efforts. Its updating after the Second World War, and the 1960 addition of the names of Flock House trainees who had died in the Second World War, reveal persistent community esteem for the place. Its ongoing use as part of Anzac Day services, and care demonstrated in the maintenance of the monument and surrounds, shows the value the community holds for the place. The memorial was also the focus of local First World War centenary celebrations.
- (f) The potential of the place for public education
  The prominent location of the memorial in a central part of Bulls (High Street is
  also State Highway 1), enables easy access to the site. The memorial retains
  its original site, form, inscription and associated symbolism giving contemporary
  visitors the chance to reflect on the place of the war in the Bulls community.
  The park-like setting enhances the opportunity for contemplation by visitors to
  the place.
- (h) The symbolic or commemorative value of the place
  The local commemorative function of the place is important. The memorial
  symbolises the sorrow in the loss of local people in world wars and
  commemorates local pride in their sacrifice for the Empire. While not apparent
  on the monument, the commemorative function of the place has changed over
  time, now serving as a place to honour all war dead. The place remains an
  essential part of local Anzac Day observances since its unveiling on Anzac Day
  1921.

#### **RIVER SIGNAGE**

BCC funded the Trust \$1000 in the 2017/2018 Community Initiatives Funding Grant:

**ORIGINAL FUNDING DESCRIPTION**; Athol Sanson is going to get UCOL students to develop the landscaping plan for Funnell Reserve to come up with a sign marking access to the River.

The design agreed on was to replace the sign by the water treatment plant and the didymo signs, I have spoken to Horizons and they agree this is their responsibility as they are Horizons signs.

I would like permission to use this money to upgrade the sign pictured below, designing it so the sign includes the new A-Bull logo, works in with the new town signage and plant some low growing flaxes below it.





#### Report to Council, June 2020.

This Council meeting will see the adoption of the Annual Plan for next year. This has been a very difficult discussion with Council balancing the desire to reduce the rates demand against the need to fund committed programs and to support the local economy.

We started with a rating increase position of around a 3.6% increase on average, we then adopted a series of cost saving measures where all budgets were scrutinised and then we had to add back in such things as the additional allowance for the Bulls Community Centre and unforseen costs such as the repairs to the Marton B and C dam walls. The irony is that we ended up back at a figure of 3.63 %. There has been interest around why we decided not to go out for a formal submission process around the annual plan setting. Like many Councils it was done on the basis that we were following the Long Term Plan or Long Term Plan Position with no major new works planned. The focus would then be on developing the next LTP.

I agreed after many discussions with staff to support the decision at Council. I did so on the basis that we would have a public meeting with full transparency over the Bulls building costs and I note that we are still to go back to the community with a summary of some of the lessons learnt from this build, something that I have asked staff to do on completion of the project. It will be a marvellous facility but is vitally important that we learn from it particularly when we have other building projects that are imminent. I also agreed on the basis that I would still have, prior to the adoption of the plan, a series of public meetings right throughout the district to provide feedback to the process and to inform our communities. I do this every year, holding about 15 community meetings. Unfortunately, the lockdown process meant that this could not happen and I will go back to these meetings early in the new Council year to start the Long Term Plan discussion.

We have just completed the District Plan Change, Rural to Industrial Land hearing process. A considerable amount of time has been spent on it, I congratulate the submitters both those in support and in opposistion for the standard of information presented and for their courage to put their position forward. It is not an easy process. The decision now sits with the Commissioner

who has adjourned the meeting to allow the independent planner to give further advice prior to any decision.

Over the last few months I have thanked on a general basis everyone for the support that has been given to provide welfare during the pandemic and support around the effects of the drought. Two awsome ladies, Emily Raynor and Lindsey Robinson want to publically give the chance for us all to say thanks. They have planned an Essential Workers parade in Broadway from 9.30am-10.00am as part of the "Doors Open Marton" event on the 27th of June in Marton. Essential workers are encouraged to meet 8.45am at Marton Park, and to wear their uniforms in the march giving us all the chance to say thanks for a job well done. The road closure for the parade will finish at 10.00am allowing everyone to stay and enjoy the event atmosphere, support local businesses including those partaking in the local market on the Village Green.

Equally we have may more amazing people in our community, Lucy Skou with Brenna O'neil and their team have said that the new park build, a project with a cost of in excess of \$1 million dollars, will happen this summer. How cool is that! These projects are never easy the heartache, committment that is required to get to that stage is considerable. Many times they have probably thought this is just too tough and it is difficult to meet everyones expectations. What we need to do is support them and applaud them!

This has prompted another Community group to investigate a community-led approach to the development of the Wilson Park Playground in Marton.

In Taihape we also have a major project with the walkway linking the Memorial Park through several bridges to Papakai Park. Again there are many key people and as always I apologise to those not mentioned but Don Tantram and Matt Thomas have been amazing. This is a huge project and it follows on from the restoration work, replanting and the new lookout at Mt Stewart in Taihape. These people have given literally years of work to their communities. Council through its partnership funds will support these projects and we will continue to support the people that have the drive to make a difference.

They are not alone and there are many other projects that I could mention, the restoration of water ways, by various groups and accords, the beautification of parks, reserve work, coastal settlement work, the lists are endless and I use the above examples just to illustrate an attitude that we should be proud of.

Council has just had another meeting in Taihape over the Memorial Park build, but we are on the home stretch. This summer we will build the new ablution facilities on the park and we are in the process of construction for the new toilets in Marton. We are also in the final stages of planning with work to start soon on the replacement for the Mangaweka Bridge. Finally we are doing what we said we would do.

Last week our Chief Executive, Peter Beggs and I made the decision to protect the "Cook statue" in Marton. This was made on the basis that we received information that it was to be damaged. The future of the statue should not be my decision so I have referred it to Council who may then decide it should be part of wider community discussion. There will be mixed views and some of them will be highly emotive but lets have that discussion respectively.

Jan Harris has been employed by MPI (Ministry for Primary Industries) to assist in welfare response to the rural communities in our region. There will be a number of rural social gatherings which will be announced shortly. Jan has an amazing attitude, one that means her requests for help always seem to be met with action.

I am a member of a small group of Mayors called the Mayor's Task Force for Jobs and as a consequence we, along with three other rural councils were given \$100k as a trial to assist with unemployment. We have called our pilot program Mahi Tahi and it is being run in partnership with Nga Wairiki Ngati Apa in close collaboration with Louise McCoard of Ministry of Social Development. We are well aware of a significant number of people who have been made redundant over the last couple of weeks, so this funding has come at the right time. Hopefully by the time of the meeting I will be in the position to confirm both an expanded funding and a national rollout.

#### Yes Programme (Youth Employment Success)

Youth Employment Success (YES) is an online platform that launched in 2016 partnering with a variety of industries to offer free employment-based opportunities to 16-24-year-olds.

Since 2016, YES has seen 112 businesses across the country offering their time, close to 1,500 opportunity requests and nearly 20,000 unique visitors to them website across the country. The Whanganui/Rangitikei district platform was launched at the beginning of June, with 80 businesses so far on-board offering opportunities for our youth.

Council, along with 100% Sweet, are engaging with local businesses to offer the same opportunities to youth to connect to local businesses in a real world way. It involves a professional short video clip of business and their staff, talking about what the job entails and how the business and industry is a great career path option. Further the business can choose from a selection of real world help they can offer an interested youth. Such options include a coffee catch up, business walk through, CV review, desk shadow, internship and lots more. Each business decides what, from the offers, they can genuinely deliver.

100% Sweet further works with youth to help them successfully complete a work ready passport which covers a range of skills from the importance of turning up on time to begin drug free, first aid and basic health and safety.





#### 1 Allocation

- 1.1 The amount of the 2019/20 Small Projects Grant Scheme for Bulls Ward is \$1,254.
