## Rangitikei District Council Long Term Plan Submission

### General

Sport Manawātū is a charitable trust that was established in 1987 and has grown from small beginnings to become a substantial provider of services and events benefiting the sporting and active recreation interests of the Manawātū, Horowhenua and Tararua communities. In more recent times, this has extended to the Ruapehu, Rangitikei and Whanganui Districts through our leadership and coordination of the Regional Sport Facilities Plan. Sport Manawātū have a long and proud history of supporting and delivering on local Council outcomes. Our headquarters is located at Sports House in Palmerston North, in addition we have satellite offices based in Feilding and Dannevirke.

### Play, Active Recreation and Sport on the lives of residents

Sport Manawātū has a vision of a community where everyone is physically active for life. A recent national report highlighted that participation in sport and physical activity reduces the incidence of heart disease, Type 2 Diabetes, Obesity, some forms of cancer, depression, and dementia. In addition, play, active recreation, and sport contributes to vibrant and stimulating communities and we believe that our work would complement the Council's approach to delivering on community outcomes.

### Strategic Alignment

We are aware that the Rangitikei District along with the wider region has a rich history of delivering recreation and physical activity opportunities and sporting success. Delivery has in the past been supported by a network of partner organisations and stakeholders, and is powered by willing funders, philanthropists, sponsors, and volunteers. However, societal change means the landscape for the delivery of play, active recreation, and sport is changing.

We acknowledge that Rangitikei District Council (RDC) decisions are underpinned by the various plans and policies which are developed to enable effective decision making.

The council is clear in what it values through the agreed community outcomes below:

- Healthy and Resilient Communities.
- Healthy and Improving environment.
- Prosperous economy.
- Partnership with Iwi.

We believe play, active recreation, and sport should play an integral role in the lives of RDC residents and contributes to the outcomes listed above. The RDC in its Long-Term Plan has stated that it is facing a challenging environment, there has been public acknowledgement stating that it has been most difficult the plan put together under the Mayors tenure. Council must respond to these challenges whilst trying to reach a balance between loan and rate funding.

We feel opportunities exist for RDC to consider our sector offsetting the issues experienced by growth increases and financial restrictions.

## Economic Value

- A focus on facilities is essential. It is important that existing facilities have sufficient investment in renewals and improvements to maintain a network of fit for purpose facilities to meet existing needs. New facilities are also required to address the current shortfall and the rapid growth in population – these needs are applicable to both indoor and outdoor spaces.
- It is critical that investment meets growth. It is essential that growth in population both at the urban fringe and in the existing urban area is matched by investment in sufficient new facilities to meet the new demand that will be generated.
- The recreation and sport sector has aligned and collaborated in planning and prioritisation. Partners to the Regional Sport Facilities Priorities Plan have demonstrated that we are playing our part in making sure every Council dollar is invested wisely for maximum return in benefits to the community.

### **The Future of Play, Active Recreation and Sport**

The impacts of Covid-19 have accelerated the need for our sector to consider the future state of play, action recreation and sport to position itself for the next 20 years and beyond. Over the last year work has been underway with the sector to better understand the challenges and create a more active future through a system that does things differently and better.

Emerging themes from this work paint a picture of a system that is:

- Values-based, inclusive, equitable, fair, affordable, bi-cultural, multi-cultural, gender neutral/gender free, caring, strong sense of belonging, safe, affordable, universally accessible, universal design, cooperative, co-design.
- Collaborative through a high trust model with clear roles and incorporates new parties, innovative funding, distributed decision-making and continuously learns and adapts to changing needs, situations, and facts (data-driven).
- Giving effect to the principles of Tiriti o Waitangi through Mana Ōrite – partnership, Mana Maori – protection, Mana Taurite – participation.
- Caring and protective of the unique natural environment (mountains, lakes, seas, native bush, fauna and flora) in which people can be active and contribute to environmental sustainability through safeguarding natural resources (air, water, land) and planning the physical environment to support activity, universal access and accessibility of spaces and places to be active.

All these things have hit the sector hard, and we continue to progress partnerships with Sport NZ, councils, funders, and other local stakeholders to find solutions to help address these.

### **Rangitikei District Council Long Term Plan (LTP)**

Sport Manawātū would firstly like to acknowledge the Council and Community on the recent opening of Marton's new playground Te Āhuru Mōwai. This is an exciting piece of work that supports efforts for community connectivity and storytelling. We acknowledge the efforts of volunteers, officials, and other key stakeholders who contributed to its development and hopefully its long-term success.

We see play opportunities as being crucial to forming lifelong habits to be physically active. Play can be defined as a self-directed activity which a young person can freely choose, usually for its own sake. However, Play is not just about the provision of fixed assets in the form of playgrounds. Commitment to playful communities requires consideration of all the decisions and factors made by Council and its partners that create space, time, and permission for our whānau to play.

Research shows that play has many benefits for children, families, and the wider community.

- Play contributes the largest number of physically active hours for 5–18-year-olds on a weekly basis.
- Play is vitally important for a young person's resilience and wellbeing.
- Playful childhoods lead to healthy, happy, active lives.

It has been taken for granted that play will always be a part of New Zealand childhoods. However, levels of play are in decline due to shifting cultural values, increasingly sedentary behaviours, family circumstances, urbanisation, and fears about children's safety. Through its network of parks and open spaces, RDC can be a significant catalyst for play. We would also urge Council to give consideration through its numerous roles and services as to how the Council creates opportunities for more playful communities. An integrated planning approach through a play lens would ensure there is more opportunity to activate spaces and places and create environments that encourage physical activity through play.

### **Sport Manawatu recommendations/feedback on the LTP**

SM acknowledges the historical status of the Taihape Memorial Park Grandstand, and we can also appreciate its significance as a part of District history. A consideration to the proposal is how it is not only valued but how it contributes to the activities offered at the site, and the experiences that participants and supporters take away from visitations.

The fact it already exists is also a key factor as to why we believe it should be restored and protected into the future. We see the value in having an independent assessment of the project to determine feasibility and should the evidence stack up for the proposed development, it will reassure external funders that any investment going forward is justified. This also follows the Sport Facilities Plan investment decision making framework which is outlined further into this submission.

A challenge for the Council however may arise should the proposed restoration costs exceed 70% of the total costs needed to build a full replacement and understanding what impact it may have on opportunity costs that may support other groups and future sector projects. We support the councils view of locating new amenities on a complementary site location in the future. SM values protects that support user demand and encourage and empower District residents with access and opportunities to be active for life.

### **Investment into the Regional Sport Facilities Implementation Plan**

SM are seeking investment for the Implementation Plan coordination role, to help us maintain momentum with the Regional Sport Facility Plan (RSFP). The Chief Executives which include members from Palmerston North City Council, Horowhenua District Council, Tararua District Council, Manawātū District Council, Whanganui District Council, Rangitikei District Council and Ruapehu District Council adopted the RSFP in 2018.

The RSFP was prepared by Visitor Solutions in 2017, coordinated by Sport Manawātū, Sport NZ, Sport Whanganui, and a steering group comprising of representatives from each of the seven councils. The process involved an assessment of over 500 facilities, as well as a research and consultation process, and code-by-code analysis of over 400 sport clubs across the region.

Led by Sport Manawātū, the plan was also jointly funded by the seven councils, including Sport NZ, Sport Whanganui and Eastern and Central Community Trust. The Rangitikei District Council contributed \$3,338 (excl. GST) towards the plan's development, with the Chief Executives signing off on the plan in 2018. The purpose of the RSFP is to:

- enable better decision making about sport facilities, spaces, and places.
- provide rationale for investment into priority facility projects to renew, replace and replenish facilities so they are future-proofed, fit for purpose and well-used.
- foster local collaboration between private providers, community, and schools to ensure planning and development is coordinated and aligned.
- support better use of facilities, spaces, and places through the provision of great sporting opportunities.

Importantly, the process was not intended to replace decision-making processes for individual stakeholders or detailed, site-specific investigations, but to inform and make recommendations to assist in the prioritisation of facility projects in line with the agreed approach. The planning framework is intended to be applied collaboratively across the seven councils and used by funding agencies to assist with funding allocation. A funding assessment approach has been developed that promotes the collaborative engagement of key stakeholders including community funders, territorial authorities, regional sports organisations, facility trusts, clubs, and education providers.

### Regional Leadership

Sport Manawātū believes it would be well placed to support community activations in partnership with council and the community. We have strategic partnerships with four District councils across the region with each having its own point of difference. We also maintain links to central government through Sport NZ investment, and hold relationships with funders including the Lion Foundation, New Zealand Community Trust, Department of Internal Affairs, and Eastern and Central Community Trust. Importantly, we have trusted relationships with RDC staff and the local community through the RSFP implementation plan steering group.

### Implementation Plan MoU

The Steering Group have supported the development of a robust, evidence-based Implementation Plan MoU. The Implementation Plan MoU applies the framework and considers the code-based recommendations alongside quantitative evidence to determine key regional priorities. Having consulted with the steering group on the RSFP priorities in October 2019, the RSFP moved into the important implementation phase. The Implementation Plan MoU (2-year term reviewed annually) sets out the overall terms, conditions, expectations, and obligations of the partners (seven councils, Sport Manawātū, and Sport Whanganui). It requires a funding commitment from each of the local authorities to establish a dedicated leadership role with Sport Manawātū to progress the agreed actions.

Sport NZ will be supporting the implementation phase supporting Sport Manawātū with targeted investment, resources, and advice. Through supporting the Implementation Plan, partners receive additional benefits which are outlined in MoU. This includes access to Sport NZ funding (by application) for planning work including feasibility studies for priority projects. The Horowhenua District Council, Manawātū District Council, and Palmerston North City Council have committed to funding the coordinator role. Sport Manawātū along with and Sport Whanganui are currently coordinating efforts to secure a signed commitment from the other Councils.

### RSFP alignment to Sport NZ Spaces and Places outcomes

Sport New Zealand aims to get more young people and adults into sport and active recreation and produce more winners on the worlds sporting stage. It does this through its strategic approach for Community Sport and High-Performance Sport outcomes. Spaces, places, and facilities for sport is one of five strategic priorities in the Community Sport Strategy with a goal to develop and sustain a world leading community sport system where the need of the participant and athlete is the focus. The drivers for taking a regional approach to facility planning can be one or more of the following:

- The desire of funders to invest wisely in identified priority projects that will make the most impact.
- An ageing network of facilities needing refurbishment, re-purposing, replacement, or removal.
- Changing demographics within a community, such as an increase in the population.
- Changing participation trends nationally and within a region requiring new types of facilities, or a new use of an existing facility.
- A growing acknowledgement that there is a hierarchy of facilities – regional, sub-regional and local – and that regional collaboration is the only fair and reasonable way to build and manage regional and sub-regional facilities.
- Increasing expectations of users and user groups.
- The risks inherent in focussing on and responding to the wants rather than the priority needs within a region.

### The value of the Regional Sport Facility Plan and Strategic Partnerships

Sport Manawātū believes the sport sector is demonstrating a maturity in creating a strategic partnership approach to facilities planning and supply across the region. The RSFP steering group are in a unique position to oversee a number of regional and sub regional projects, share valuable learnings that will benefit the sector long term, and crucially play their part in making sure every council dollar is invested wisely for maximum return in benefits to the community. The Implementation Plan MoU will give priority to low participation groups, Women and Girls and those with disabilities, promote shared use of multi-purpose facilities, and supports school/sport partnerships, involving community use of facilities.

### Council Investment

Sport Manawatu is seeking that:

- The Rangitikei District Council becomes a signatory to the proposed Implementation Plan MoU, which outlines key priority projects for the region.
- Commits \$2,872 annually for the RSFP leadership and coordination role.
- The Rangitikei District Council continues to support the RSFP outcomes by committing a representative on the Steering Group, noting that the Ruapehu District Council Chief Executive will appoint the Council's representative to the Steering Group.

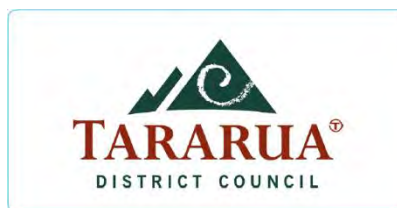

## 1. Background

Sport Manawātū, Sport Whanganui and Sport New Zealand, together with the seven local authorities that make up the Manawātū and Whanganui region have developed and endorsed the Regional Sport Facility Plan (“the Plan”) to provide a high-level strategic framework for sport and recreation facility planning across the region.

The Plan is designed to provide direction on what should be done and crucially, what should not be done, and to focus thinking at a network wide sports facilities level with emphasis on national, regional, and sub-regional assets, while also capturing local level facility data.

## 2. Introduction

The Plan now moves into the important implementation phase with commitment from the local authorities and other parties to establish a dedicated role within Sport Manawatu to progress implementation of the Plan. This involves achieving the proposed priority actions detailed in Appendix 1.

This Agreement outlines the terms and conditions under which the Parties, outlined in Clause 4.0, will collaboratively work towards the delivery of the outcomes, priority projects, guiding principles, decision making framework and criteria identified in the Plan.

## 3. Date of Agreement

This Agreement shall commence on the date that the parties have signed it (“the Effective Date”)

## 4. Parties

**Palmerston North City Council (“PNCC”)**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Manawatu District Council (“MDC”)**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Horowhenua District Council (“HDC”)**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Tararua District Council (“TDC”)**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Rangitikei District Council ("RTDC")**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Ruapehu District Council ("RDC")**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Whanganui District Council ("WDC")**, a territorial authority constituted under the Local Government Act 2002 and an approved organisation controlling community infrastructure planning under the Local Government Act 2002.

**Sport Manawatu - Regional Sports Trust**, an incorporated society constituted in 2003 and is responsible for facilitating and guiding non-profit sport and recreation goals in the Manawatu region.

**Sport Whanganui – Regional Sports Trust**, an incorporated society constituted in 2003 and is responsible for facilitating and guiding non-profit sport and recreation goals in the Whanganui region.

**Sport New Zealand, ("Sport NZ")**, constituted on 1 January 2003 under the Sport and Recreation New Zealand Act (2002) and as an approved organisation representing the government interests. Sport NZ provides leadership in research and the development and implementation of policies that recognise the importance of sport and physical recreation to New Zealand. It has partnerships with key organisations in the sport and recreation sector (primarily national-level sport and recreation organisations and regional sports trusts) to help achieve its outcomes.

## 5. Term

The term of the Agreement is from the 01 July 2020 until 30 June 2021, representing three years of Territorial Local Authority, Funding Agencies, Sport Manawātū, Sport Whanganui and Sport NZ investment in the Plans implementation. Should the majority of parties agree, the Agreement could be renewed for a further three-year term.

## 6. Funding and Resources

### 6.1 Territorial Local Authority Funding

Each Territorial Local Authority will contribute funding towards a specific role to lead implementation of the Plan to a combined total of \$50,000 per annum for the Term of the Agreement.

## 6.2 Sport New Zealand and Sport Manawatu Funding and Support

Sport New Zealand will contribute funding via Sport Manawatu's investment schedule to support implementation of the Plan. The Parties will also receive additional benefits from Sport New Zealand including:

- Access to a free and open source Facility Audit Tool (SFA-NZ) which will be a repository for all the regions facility data and information. This tool which is compatible with Sport NZ's Insights Tool will provide a comprehensive planning tool for projects at a local, district, regional and national level. The RST will encourage and support councils to keep the based facility data up to date which will provide costs savings at such time it is agreed to review a regions plan.
- Access on application to funding to support from Sport NZ for those projects as identified as being a priority from the Regional Plan. Funding would support project needs assessments, feasibility studies, business cases and design reviews.
- Use of Sport NZ's Project Peer Review Service for independent review of project concepts and plans, feasibility studies and business cases and funding applications.
- Relevant facility automatic registration onto Sport NZ's National Facility Benchmarking Tool which, through key performance indicators provides opportunity for comparative facility conversations that improve operational efficiency.
- Free Sport NZ time and advice/support through Sport Manawātū to build the capability of those actively working into sports and recreation spaces and places provision. Regional Spaces and Places working groups will be able to share best practice between regions, facilitated by Sport NZ.

Sport Manawātū will be responsible for leadership and management of the specific Plan implementation role and will work with Funders to gain investment for other costs associated with the Plan implementation role.

## 7. Provision of Services

Sport Manawatu will provide the following services in a professional and timely manner in accordance with the instructions of the Parties and any additional services as may be agreed between the Parties under the terms and conditions of this Agreement:

- a. Provision of support including advice, guidance and evidence gathering for the development of feasibility assessments and business case reports to guide the successful execution of the decision-making framework. This will include consultation on Local, District and Regional facility hierarchy of needs.

- b. Advocate with funders and investors for facilities that reflect the principles of the Plan.
- c. Arrange peer reviews for Regional facility development concepts only e.g. feasibility assessments, detailed business case and design concepts that are related to identified priority projects.
- d. Assist with investment negotiations alongside stakeholders for spaces and places project developments and utilisation.
- e. Lead the development of a regional funding policy.
- f. Share knowledge including resources specific to sports spaces and places.
- g. Increase regional understanding and optimisation of spaces and places including providing regional sporting trend information, opportunities to benchmark outcomes and usage data, to understand demand and inform decision making.
- h. Facilitate discussions with user groups and gather evidence on behalf of Territorial Authorities where a conflict of interest may arise.
- i. Lead the review of the Manawātū Whanganui Regional Sport Facility Plan in 2020/21 to ensure it remains relevant and in line with sporting and demographic trends.

## 8.2 Obligations of the Parties

- e. Sport Manawātū in partnership with Sport Whanganui will guide and support council staff and facility proponents through the Regional Sport Facility Plan priority actions during the agreed implementation plan period.

## 9. Regional Sport Facility Plan Steering Group

The Parties will establish a Steering Group which includes representation from each contributing organisation to oversee implementation of the Strategy. The role and functions of the Steering Group is to:

- a. Provide leadership and guidance to Sport Manawātū in implementation of the Plan.
- b. Review and prioritise Plan recommendations and priority actions.
- c. Promote the Plan within the Region and through key stakeholder organisations.
- d. Monitor, review and provide regular updates on the progress in implementation of the Plan.
- e. Review and recommend key regional facilities projects based on application of the key principles, assessment, and prioritisation criteria.
- f. Facilitate communication with each of the executive groups from the organisations they represent.

As reports on the costs of water upgrades goes it assumes a lot, it does not go into the costs of what it would cost us the consumers if the govt goes ahead with the three waters system.

In all the other countries that have tried that system have found that it does not do better than district councils ! If the govt idea goes ahead then those with tank, stream and bore supplies will be paying the similar amount for water as the urban ratepayers with no real benefits.

The danger is that any water board or corporate that is established will be able to charge whatever they like and even sell off parts to overseas corporations that will only look at it as profit making, not building for the paying consumers.

A better course would be to leave the councils in charge and be able to apply to central govt for major funding of what they are required to do, thereby alleviating the extra charges for water to the ratepayers.

The rivers and drains can stay with Regional councils and the District councils can manage the waste water and potable water supply in urban areas.

But we must remember that the continual practice of spraying roadsides, drains and other watercourse banks along with dropping poisons into land and streams damages those water courses ability to retain life that keeps the water clean.

Nobody seems to even put that into their equations whenever they talk about water, all they seem to look at is the money..

Years ago we the people funded the building of our power production, distribution, also our phone systems and public transport that have been divided, sold off to overseas with a lot of land and housing and are now paying through the nose for the supply of our infrastructure. So there has been little or no benefits to the paying population with most of the money going overseas and I can visualise the same thing happening with the three waters concept.

Please let us keep control of our areas as each District is very different from another and have a different approach, and let central Govt fund the major works as applied for, as they will have to pay the start up costs and running costs of the new three waters board anyway and that money would be better spent on infrastructure by the councils.

8. Should Play Centre cease to exist, that site


It was **suggested** Go Bus move to the saleyards. **No-one present wants housing built on this site for our elderly.**

Thanks for that.

I would just like to add the following:

I believe the existing rules are archaic and elitist. They seek to preserve a way of life in rural areas that for the most part no longer exists. In our area at least, more and more farms are amalgamating with a commensurate decline of the owner/farmer living on the farm. Instead there is an increase in absentee owners, whether corporate or larger family businesses. I am not making a judgement call on this as it is presently the way it is. However this trend inevitably leads to a decline in community as transient farm staff do not have a long term stake in the health of that community.

The second point I would like to add is that the development of fast broadband connectivity, even in areas such as ours – Pukeokahu – now allows people to work remotely from places of employment. To live in an area such as ours no longer requires you to be actively involved in the farming economy. This I think is a good thing as it brings more diversity to rural communities.

Kia Ora Andy, Gill, Angus

I am not sure whether this is a subject for the LTCP or not.

What I would like considered is a change to the ruling around the minimum sub-division needing to be 2 hectares. Now I know that you can apply for a dispensation, however I am told anecdotally that even when you get a dispensation it still means that every thing you want to is harder than what it is if you have the 2 hectares. Our daughter was negotiating to buy a small block from a neighbour but in the end the neighbour walked away because it was just all too hard.

I believe I understand that part of the reasoning is the Council's desire to limit the urban sprawl of lifestyle blocks, and I understand this. However the reality of life on the ground out in places like Pukeokahu is that we are still losing people – the school role is down to 7 – and most farms when they do hire staff seem to prefer singles, certainly not families. Consequently we – River Valley - are not the only ones who struggle to attract and especially retain senior staff. There is a lack of casuals for the agricultural sector as well.

I have a suggestion.

That suggestion is that the rule for a minimum of 2 hectares only apply within a fixed travel distance of the nearest urban centre of say over 200 people. Once the fixed travel distance is over let us say,

25kms from town, then the size of the block can be smaller – possibly 1 hectare or even under that. This policy change could increase the willingness of many farmers to sell small blocks.

I know many people find 2 hectares a pain in the backside, too small to be of any use, but unfortunately needing a great deal of work to be kept tidy.

On a more global basis some interesting research has been done by the Post Carbon Institute. The report is here - <https://www.postcarbon.org/publications/the-future-is-rural/> - It is available on that page as a free download. If they are correct, and I suspect they are, then the changes to come in where and how people will live is going to be way greater than we presently imagine. I don't believe any research of this nature has been done as yet in New Zealand.

To me strong diverse communities (not just towns) are critical to the resilience of rural New Zealand. It is something that the council should be considering and formulating policy around.

To Whom It May Concern,

We would like to support the submission made by local businesses for the recommendation for an effluent and truck wash site.

Our company CR Grace Limited and sister company Glen Oroua Livestock (2000) Ltd operating 10 livestock units successfully carting approximately 1.5million head of bovine and ovine animals per annum. We have a clean record with NZTA and our Operator Rating is 5 stars.

In my 20 years working for the company we have not received an effluent fine until we received 2 within 3 weeks of each other late last year. In both cases the trucks were parked roadside for 20-60 minutes while the police officers completed their safety checks. During the process it was pointed out that there was a leak from the tap at the effluent tank. One looking at the video the leak could only be described as a 'dribble' at the joint where a stone or bit of grit may have got stuck in the valve. After the wait period there was a small amount of effluent pooled on the ground, it could be estimated to be less than a litre or so (when the size of effluent holding tanks on trucks can be up to 300 litres). Each fine is \$600 under the legal bracket of 'insecure load' even though there was no livestock on-board truck at the time.

Effluent volume estimation is not easy and requires all of the experience of the drivers complicated by trying to approximate volume of effluent on board, stock standing time prior to transport, time of the year and seasonal stock movements. There is an industry trend where farmers are no-longer standing their stock for the required minimum of four hours but for no more than 12 hours before travel, as per the Code of Welfare for Transport within New Zealand and The Animal Welfare Act 1999.

We estimate that the majority of stock collected come straight off grass or is only stood for 2-3 hours maximum.

Issues typically associated with effluent spillage as outlined in accordance with the National Stock Effluent Working Group's Industry Code of Practice for the Minimisation of Stock Effluent Spillage from Trucks on Roads such as:

- Potential safety hazards to smaller vehicles, motorbikes and cyclists undertaking cornering and braking manoeuvres
- Damage to the road surface caused by effluent
- Pollution of local waterways and sensitive environments
- Health hazard concerns

At the moment there is not an Effluent Dump site anywhere in the Rangitikei District that can be accessed by our fleet which are all permitted for 54tonnes. The site on Turners Road in Feilding is not on State Highway and so that road is not permitted to be used by a 54t unit. There is 1 site at Waverley on state highway but we do not have a big client catchment in that area. There is another one on the Napier Taupo state highway but again not a permit route nor in our area of work. 99.9% of our effluent is held on the truck until it is able to be dumped at bottom of Ngauranga Gorge, Wellington.

On the 8th March 2021 NZTA declared that eight companies would be used as a pilot scheme for compulsory GPS tracking and Electronic Logbooks. This would then be rolled out across NZ affecting all Livestock movements. This means that is our drivers are outside their electronic logbooks they would face prosecution or as a company our loss of our Transport Service Licence.

Effluent dumps nationwide are insufficient in number which means drivers have to detour to sites adding very valuable time to their tight logbook restrictions.

When taking an enforced 10-hour break, public image and perception is compromised should stock trucks be parked up at service stations and roadsides often bringing public backlash due to the effluent smell with public complaints. Drivers are often abused and asked to move on.

Consideration should be given to the drivers inability to access dump sites, as a transport company writing this submission is the only influence we have on the availability of more appropriate in-transit dump sites on main stock routes in one of NZ's busiest agricultural districts. Due to the lack of sites on a wet rainy day with cattle full of crop feed drivers can see in their mirrors effluent being splashed all over the cars behind on every left or right turn the truck takes.

As a transporter it would never ever be our intention to commit an infringement under the terms of "operating a motor vehicle with insecure load" - with the presumption of guilt being unjustified in both cases here simply due to the lack of infrastructure in the region.

I know the site proposed is in Taihape, however I would like the Council to look at the appropriateness of the suggested location. I believe there would be more support to a submission if the effluent site for the Rangitikei District Council was in Bulls. There are no trucking companies carting livestock based in Taihape the most northern one is Ray Coles based in Mangaweka and he's not going to drive further north to Taihape to dump when he is based south of there.

Trucks within the region going from plant to plant or farm to farm would be better serviced by a site in Bulls which is more central to where the transport activity is. I don't believe HWCT, CRG, Glen Oroua, Glenn Carroll, etc would use a site in Taihape nearly as often as they would if it was more central.

**SUBMISSION ON RANGITIKEI DISTRICT COUNCIL'S LONG-TERM PLAN 2021-2031 CONSULTATION DOCUMENT  
– Impact Collective Rangitikei, Ruapehu, South Taranaki and Whanganui.**

**Submission on behalf of the Impact Collective Rangitikei, Ruapehu, South Taranaki and Whanganui**

The Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui is a collective of Iwi, local council, DHB, Police, Ministry of Social Development and Te Puni Kōkiri representatives, who initially formed in the immediate aftermath of the nationwide level 4 lockdown response to the COVID-19 pandemic. Since then, through an integrated social governance model, the impact collective has continued with the renewed purpose to nurture a regenerative economy within a thriving community that creates wellbeing for all people, our whenua and the planet.

Across the Ruapehu, Rangitikei, Whanganui and South Taranaki regions, we are working with a number of organisations and government agencies towards achieving better wellness outcomes and delivering connected services to our communities. Traditionally in a pre-COVID environment, many of these organisations operated in institutional and territorial silos. However, throughout the response and recovery to the Covid-19 pandemic, the organisational and territorial boundaries were removed, and our communities were placed at the centre. The coming together of organisations to address social (health, housing etc), economic and environmental factors ensures that all of the community, all of a whānau, and all of an individual are considered as part of the decision making process – no one element is to be perceived in isolation.

The Impact Collective are seeking to keep this sense of integrated social cohesion and governance and ensure that this becomes the 'new-normal' in response to the impacts of Covid-19 in Aotearoa New Zealand. To enable this, we are creating a 'Impact Collective Operational Team' to work with our communities, to baseline a rohe wide 'Community Wellbeing and Equity Profile'. This baselining will bring together the organisational statistics which are aligned to the 17 United Nations Sustainable Development Goals (thinking Global), Treasury's Living Standards Framework (aligning Nationally) and to a localised Whānau Ora framework (acting regionally/locally), alongside the 'stories and narratives' which are collated during community wide engagement. By collating the 'Stats and the Stories' for the communities, we are able to present a holistic wellness picture of our communities to the membership of the Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui, the New Zealand Government, and most importantly, our communities. Through initial scoping of this mahi, we have identified those that have gone before us in community co-design for wellbeing. We have engaged with the Southern Initiative, the Waikato Wellbeing Project and the Ruapehu Whānau Transformation programme. Each one of these initiatives identified a 'lynchpin organisation' who sponsored the mahi in terms of driving the movement for change. The Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui, whilst in this initial phase has been sponsored to date by the Whanganui DHB and MSD, this mahi is not about a person, or organisation, it is about enabling our communities to thrive – to better plan and organise – in a partnered, all of government, iwi and community tailored, localised approach to meet the needs of the communities.

Following baselining, in phase two, we will be able to work alongside our communities to co-design local services and supplies, which enable them to live more meaningful and healthy lives in our thriving communities – this maybe supporting a strength based approach to design, or supporting addressing community concerns/issues.

### **1.1 What is the purpose of the Impact Collective?**

The purpose of the impact collective is to nurture a regenerative economy within a thriving community that creates wellbeing for all people, our whenua and the planet. This will be achieved by breaking down organisational and territorial boundaries and focusing on our communities holistically – through economic, social and environmental determinants. It is not about viewing our communities solely in terms of health, or wealth, or access, or vulnerability, but rather in terms of the whole person – a whānau ora approach. This will ensure that our resources, our services and our collective wellbeing is equitably shared across our rohe, founded in the principles of Mātauranga Māori.

### **1.2 Who does the Impact Collective serve?**

The Impact Collective serves all people within the porous boundaries of wider rohe of Whanganui, Rangitikei, Ruapehu and South Taranaki. This enables communities to participate should they align to the purpose of the Impact Collective, tūrangawaewae to the rohe, or are tangata whenua. It serves to address inequities in service provisions, resources, capability and capacity, through a collaborative approach operationalised through a community codesign methodology<sup>1</sup>.

### **1.3 How will this help the Rangitikei community?**

The initial baselining work will enable the Impact Collective Operational Team to present a holistic wellness picture of our communities to the membership of the Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui, the New Zealand Government, and most importantly, our communities. Traditionally, we have worked on anecdotal evidence or statistics to drive change delivery. In order to all work from the same starting point, the baseline is imperative. We need to try something different, if we are to make better progress than we have until now.

It is time to go “with our community” to find the next generation of solutions and stop “doing it to our community”. Our wider region has the depth of collaborative relationships and connection needed for this to succeed. The team’s focus will be research, community engagement and identification of pivotal regenerative projects/initiatives. This will create opportunities for phase two which has similar links to the Southern Initiative, the Waikato Wellbeing Project and the Ruapehu Whānau Transformation Plan.

## **2 Iwi at all levels**

It is important for the Impact Collective that we have the support, representation and leadership from Iwi at all levels of the team. At the Governance Level, we have the Chair from Te Ranga Tupua represented, which enables the dissemination of information and support engagement directly with the Iwi Chairs and Chief Executives. An operational Co-Lead role (the Integrated Iwi Impact Strategist) is currently being sought to be one of two co-leaders for the Impact Collective Operational Team – the purpose of this role is to manaaki and increase whānau, hapū and iwi engagement in the mahi, while developing long term partnerships and relationships. By doing so will ensure the voice of whānau, hapū and iwi is represented in the Community Equity and Wellness Profiles which will led to any concerns or strengths identified to be supported in phase 2 of this mahi.

## **3 Update**

The first 2021 hui of the Impact Collective Governance Leadership Team was held on the 29<sup>th</sup> of March 2021. The Governance team had representation from Ruapehu, Whanganui and Rangitikei District Councils (Mayors or Chief Executives), Regional Commissioner MSD nominee (Taranaki), Chair Te Ranga Tupua, NZ Police Ruapehu and Whanganui and the Whanganui District Health Board Chief Executive. At the first hui, financial contributions from the Whanganui District Health Board and the Ministry of Social Development (MSD) were confirmed, with the representatives from the remaining members seeking leave to work through the commitment that they are able to contribute. All members who attended the hui who had previously committed to the mahi recommitted to the Impact Collective - Rangitikei,

Ruapehu, South Taranaki and Whanganui. The Chair of Te Ranga Tupua sought to go back to the Iwi Chairs and present the impact collective to seek endorsement – this mahi is ongoing, with the Chief Executive of the Whanganui District Health Board to present to the Iwi Chairs in the coming weeks. Since this hui, confirmed oral or written support has been received from Ruapehu, South Taranaki and Rangitikei District Councils, Regional Commissioners MSD (Taranaki and Manawatu), Individual Iwi Chairs or Chief Executives, Area Commander NZ Police and the Whanganui District Health Board. We have further invited the Regional Director of Te Puni Kōkiri to be a member of the governance team.

Immediately following the hui with the Impact Collective Governance Leadership Team, the Chief Executive of the Whanganui District Health Board and the Integrated Community Impact Strategist presented the mahi to the Regional Public Sector Leads. This presentation was well received, and on-going conversations are being held to enable this mahi to have regionally supported funding through the RPSL priorities programmes, and national funding through the Place Based Initiative funding.

Since the meetings, a MoU has been signed between Whanganui District Health Board and MSD, with the initial funding coming through from MSD to enable the creation of a Charitable Trust, a website, the initial data and analytics draw, and initial employment of the Integrated Iwi Impact Strategist, the Visual Storyteller and administration support (for both the team and the Governance Leadership Secretariat).

A local legal firm has been engaged to support the creation of the Charitable Trust and this will be completed within the next few weeks. Following the Trust's formulation, this will then be incorporated, and the Impact Collective Governance Leadership Team will become the Trust Board.

#### **4 LTP Context**

The Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui collective is seeking the following considerations from the Rangitikei District Council's Long-Term Plan Consultation:

1. A commitment from the Rangitikei District Council to participate in the Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui.
2. Through this commitment, to provide a signatory to the Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui Trust, who would participate on behalf of the Rangitikei District Council as a Trust Board member, and as a member of the Impact Collective Governance Leadership Team.
3. Consideration about a financial contribution towards the operational costs of the Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui. Annually, the costs are in the vicinity of \$600,000 which is currently covered by the WDHB and MSD. In terms of future proofing the success of the Impact Collective - Rangitikei, Ruapehu, South Taranaki and Whanganui, it is important that all members contribute to the operational costs, either in direct funding into the Trust, or 'in-kind' contributions through workforce, infrastructure, or facilities – an approximate contribution from each member organisation would be circa \$50,000pa.
