#### 1 Work Completed

1.1 The following work was completed by Taihape Plumbing from 16 April 2020 to 16 September 2020:

18/5	6 Monthly Checks - Run lines, check tank flows and run sluices. Check
	pressures. Mangaohane A, B, C, D & E tanks.

- 19/5 Run lines, check tank flows and run sluices. Check pressures. Mangaohane F tanks, Mangohane/Kelly Land Co Rim rocks, Kelly Land Co tank 1, 2, 3 & 4.
- 20/5 Run lines, check tank flows, run sluices and check pressures Mako 3, Mako woolshed, Hunt, Orum 2, Orum 1, Big Hill Tee, P Batley, Pukerimu and Surge Hut.
- 21/5 Run lines, check tank flows and run sluices on Hennah block, Kaiangaroa, Kara Wipaki's and Moore's.
- 22/5 Run lines, check tank flows and run sluices. Makokomiko Deer block. Orum's John Gilbert's, Jock Stratton's and Rob Stratton's.
- 23/5 Mangaohane Station. Fit new connection through tank. Fit new inlet float valve and reinstate water supply.
- To dig up leak in Pukerimu (100mm steel). Fit S/S repair clamp and reinstate.
- Run lines, check tank flows, run sluices and check pressures. John Batley's, Durrant's, Hiwera, Rob Collier's, Andrew Duncan's, Tama Wipaki's, Len Gilbert's and Thompson's.
- 26/5 Run lines, check tank flows and run sluices on Barry Thomas, Mary Mako's.
- 27/5 Run lines, check tank flows and run sluices. Clean up Rhino. B Duncan's, D Duncan's, Anstis and Whake.
- 23/6 Carry out Monthly Check.
- 28/6 Len Gilberts Britton tank low flow. Look for leak Len Gilbert and John Bird's properties.

- 29/6 Run lines looking for leak Thompsons, Tama Wipakis and Len Gilberts properties. Run bypass Thompson Tee check flow Britton tank site. Remove 150L/m Marric Pungatawa line for repairs.
- 6/7 Load up gear. Locate leak in 80mm H/P PVC. Dig up and drop line. Cut out leaking joint. Repair with section of pipe and gibbolts. Block to side of bench. Reinstate water and backfill. Unload.
- 29/7 To carry out Monthly Check.
- 10/8 Start of 9 Monthly Checks. Run lines, check tank flows and run sluices on Mangaohane A, B, C & D tanks.
- 11/8 Run lines, check tank flows and run sluices on Mangaohane E & F tanks and Kelly Land Co 1, 2, 3 & 4 tanks.
- 12/8 Run lines, check tank flows and run sluices Peter Batley's Big Hill, Makokomiko and Pukerimu.
- 13/8 Run lines, check tank flows and run sluices Hennah block, Kaiangaroa, Kara Wipaki's and Moore's.
- 14/8 Run lines, check tank flows and run sluices Mako Deer block, Orums, J Gilbert's, Jock Stratton's and Rob Stratton's.
- 14/8 To renew marric valve at Rob Stratton's tank site.
- 15/8 At Thompson's Tee. To renew two 150ltr/pm Marric valves.
- Durrants property. Drop line and remove temporary repair. Pump out valve box and fit new tapping saddle. Reinstate line. Run sluice. Bring up to pressure.
- 17/8 Run lines, check tank flows and run sluices John Batley's Durrants, Hiwera, Duncan's, Tama Wipakis, Len Gilbert's top farm and Thompson's.
- 18/8 Run lines, check tank flows and run sluices John Bird's 1 & 2, Britton, Pringles, Mako 2 and Barry Thomas properties.
- 19/8 Run lines, check tank flows and run sluices B Duncan's, D Duncan's, Pete Batley's (Whake) and Anstis. Clean up Rhino.
- 14/9 Carry out monthly check.
- 16/9 Mako Deer Tank Fit non-return valve, new marric valve and isolation valve at tank site.
