Athol Sanson has confirmed that the blackberry around the town boundary is being addressed by the Parks Team as well as the local environment group. However, it is not currently time for spraying due to be blackberry being in fruit.

Old Fire Station as a safety hazard

The issues with the safety of the old water tower at the fire station have been investigated and addressed.

Committee requests an update about the gardens and parks in Hunterville.

Athol Sanson has confirmed that 2018 plans for parks and reserves in Hunterville include more planting along the stream beside Queens Park (this will be native planting) and finishing off the planting by the Plunket rooms.
