As a Ward Councillor it was an honour to witness the occasion and to be part of this event, and I would like to say that if other Councillors are ever offered the opportunity to attend an event such as this that they should do so, your presence and the position you have taken will be noted favourably.

3. The Les Vincent memoirs, has an amount of \$8000, what is the total amount needed for this project or is it the amount outstanding still needed to do this job. Council has granted some money already – could this please be identified in the sheet, it will give some perspective to this grant application.

In reply:

The total sum needed (for publishing up to 300 copies) was identified as \$11,000. The application to the Community Initiatives Fund was for \$3,000 – it envisaged a successful application to the Earle Trust of \$7,000 and Creative Communities of \$1,000 (neither of which has materialised). At its meeting on 27 July 2017, the Finance/Performance Committee approved a Community Initiatives Fund grant of \$2,000 for this project (notionally to Rangitikei Heritage).
