I hope you are doing well.

I called Heather to discuss the new wastewater system annual inspections and Heather asked to get in touch with you.

I'm not sure if you are aware that the new wastewater system needs to comply with the Regional Councils rules which states, regular (annual) inspections of the septic tank and LAA is mandatory under the Service Contract between the homeowner and system supplier.

This means it is mandatory for Doughty Drainage Ltd to undertake the annual inspections of the onsite wastewater system and copies of the inspection sheets need to be supplied to Rangitīkei District Council after each inspection.
