# Description of issue to be tabled

On Sunday 11<sup>th</sup> February I was contacted by a former resident and farmer of the Rangitikei district, Mr Jeff McNeill, about helping to find the interment maps for the Tirriraukawa cemetery so that he and his extended family could place the ashes of his deceased father Mr Len Mc Neill who died some years ago, into a previously used family grave.

As this had been a locally managed graveyard he was unsure if the council had any information and or maps archived or who even owned the land. The graves on the site had been marked with wooden crosses which have weathered away and been knocked over by farm animals leaving little trace of who was interred where.

Mr Len Mc Neill had been the "custodian" of the information and was formerly a county councillor for the Te Kapua riding of Rangitikei County, but since his death the exact location of that information is sketchy at best.

On Monday following the Audit & Risk meeting in Marton I spoke with members of council's policy & GIS team and discovered that the cemetery title situated on the corner of Tirriraukawa and Ngahuinga roads was apparently transferred to council ownership with notes appearing in the gazette in 2007.

I feel that we as a community board need to work with council staff and the local community to help resolve this situation. Local knowledge and relationships both within council and in the community should be able to track down the maps in question.

### **Resolution sought**

I would like to see members of the TCB perform some information gathering within the community and RDC staff perform a similar task using council processes to try and resolve the information gap, and also work with the community to provide an appropriate level of recognition for the site.

### Outcome

Appropriate access and archiving of the Tirriraukawa cemetery interment maps, and locally agreed site management.
