1 Executive Summary

1.1 This report is to provide the Komiti with an update on issues that have been under consideration by Council over the past two months.

2 Town Centre Plans

- 2.1 Town Centre Plans in Marton, Taihape and Hunterville are well underway. Initial strategies for each town have been distributed in the community and feedback incorporated into a series of recommendations for further feedback before inclusion in the draft Long Term Plan.
- 2.2 In Taihape, the focus is for creating and enhancing the visitor experience that relies upon the iconic landscape of the Rangitikei River and its Papa Cliffs. The community consultation process also aims to establish a longer term vision for the civic and leisure facilities in the town.
- 2.3 In Marton, the focus is on creating a funky, boutique town with an emphasis on its rural heritage and the easy, affordable lifestyle. The key issue is a process to concentrate civic and community activity within the CBD to create a civic heart for the town.
- 2.4 An aligned process is underway in Hunterville with projects underway to create a pedestrian trail from the popular stopping/picnicking spots on the state highway into the amenities in the town.
- 2.5 The Komiti will be aware that the Town Centre Plan in Bulls was adopted by Council in June 2014. Council is proceeding through the design stage for a multi-purpose facility in the town centre. Currently it is still hoped to be able to secure a joint venture partner to enable Council to proceed at the site of the Criterion Hotel.

3 Regional Growth Study

3.1 The Government is funding a regional growth study in the Horizons region, overseen by the Ministry of Business, Innovation and Enterprise and the Ministry for Primary Indutres. It is expected to be complete before the middle of next year. The development of an Agribusiness strategy and responding to other actions that may arise from the study is being funded by councils within the region. Horizons is contributing 50% of these costs. Council has agreed to contribute up to \$10,000 as Rangitikei's share.

4 Strategic Water Assessment Project

- 4.1 This Project is now complete. At its meeting on 27 November 2014, Council heard a presentation from the Catalyst Group on the outcomes and findings of the project.
- 4.2 A summary of the final report has been compiled and is available on council's website, along with copies of the case studies from the seven farms that participated in the project.

5 Policies/Bylaws out for Consultation

- 5.1 At its last meeting, the Komiti was informed of a raft of Policies and Bylaw's that were currently out for public consultation. The period for submissions on these policies/bylaws closed on Friday 7 November 2014.
- 5.2 At its meeting on 27 November 2014, Council held an oral hearing for submissions to these Policies/Bylaws. Three oral submissions were heard on the proposed Local Approved Products Policy. These oral submissions, along with the written submissions received, will be deliberated at Council's meeting on 11 December 2014.
- 5.3 No submitter indicated a desire to speak on the amended Dog Control and Owner Responsibility Policy, the Significance and Engagement Policy or the Control of Dogs Bylaw. These two policies and the bylaw were deliberated on, and adopted at Council's meeting on 27 November 2014.

6 District CCTV

6.1 Implementation of the rollout is continuing. The Bulls system is now up and running. The Marton cameras have been installed and are waiting for power to be connected as are the cameras in Taihape. It is hoped the Marton and Taihape systems will be completed by Christmas.

7 Rules Reduction Initiative

- 7.1 As foreshadowed before the General Election, the Government has committed to a Rules Reduction Initiative to allow people to submit examples of property regulations (e.g. those that get in the way of renovation or landscaping) and local rules that don't make sense. While the publicity for the Initiative is directed towards individuals, local councils may make submissions to the Task Force. All submissions are treated as anonymous.
- 7.2 Submissions will be considered by a Taskforce, which will make recommendations to the Government. Taskforce members will be announced in November and, following that, a timeframe for the Initiative.

8 Broadband Project - Update

- 8.1 The Council IT team have been investigating options for improving:
 - 1. Council's own broadband connectivity; and,

2. the broadband connectivity across Marton, as Marton is not part of the Government's UltraFast Broadband (UFB) programme.

- 8.2 Through a National Library UFB connectivity project administered by Chorus, the Marton Library is able to be connected to UFB fibre at a substantially reduced cost of \$8,500 (compared with an unsubsidised cost of around \$50,000). As there is an existing UFB fibre connection between the Library and Council offices, our wider activity and operations will benefit from this arrangement. This improved connectivity will enable staff to rationalise our current arrangements, with the expected efficiencies meaning our monthly overall costs remain about the same for a substantially increased benefit.
- 8.3 Prior the elections the Government announced that a further group of towns would be added to the national UFB project. Marton was one of the towns named. Now that the new Government is in place and Ministers appointed, staff will follow up on this announcement to establish what the details are for this additional UFB rollout plan.

9 By-elections

- 9.1 No valid nominations were received by the closing date for the vacancy in the Taihape Community Board. At its meeting on 5 November 2014, the Board resolved to determine by resolution that the vacancy would be filled by Board appointment. Subsequently, Yvonne Sicely was identified as the appointee. Following the requirements of the Local Electoral Act 2001, public notice was given of this decision and her appointment will be confirmed at the Board's next meeting, on 3 December 2014.
- 9.2 The verbal resignation by a member of the Ratana Community Board noted in earlier reports has yet to be confirmed in writing.

10 Recommendation

1 Background

1.1 The aim of this memorandum is to provide the Komiti with an update on the actions and progress of the Path to Well-Being Initiative.

2 Projects

2.1 Rangitikei Heritage – World War One Commemorative DVD

The group has worked on a project to digitise the World War One memorabilia at each of the museums and historical societies in the District. This has now been completed and was launched at Majestic Theatre in Taihape, on Sunday 30 November 2014. Copies of the DVD are available from the historical societies and the Council information Centres.

2.2 Marton Community Charter

A collaboration between Ngati Apa, Council and the Rangitikei College Board of Trustees to establish a new model for the delivery of health and social welfare services in the southern Rangitikei has been developed.

2.3 Treasured Natural Environment Theme Group – Rangitikei River Accord

The group is currently in conversation with key stakeholders for this project. Further updates will be provided to the Komiti as and when appropriate.

2.4 Positive Ageing Strategy

The Safe and Caring Community Theme Group has been implementing the Positive Ageing Strategy that was put in place following last year's conference. Particularly falls prevention programmes have been delivered in Marton and Bulls which includes the provision of information about other services available to older people. The information has also been linked to gentle exercise classes that have been underway in Taihape for some time.

2.5 Marton Youth Club and Taihape Youth Hutt

After-school and school holiday programmes have continued to operate in Marton, from Centennial Park and a part-time provision has been started up in Taihape following the closure of the original Youth Hutt.

Funding for these initiatives remains fragile and is a priority for Council staff at the present time.

2.6 Path to Well-being Conference 2014

The annual conference this year will take place on 12 December 2014 at Bulls Town Hall. The theme is economic development and community regeneration. The conference is free and all are welcome. The programme is provided below.
