## 4 Matters arising

### Sainsbury's Drain

Cr Peke-Mason provided the Committee with an update on the Sainsbury's drain problems. She and Cr Sheridan had been following the issue up. The drain belongs to the Sainsburys, and is levelled to go back the other way (the levels are not quite right in the drain). A Request for Services (RFS) can be made to both Rangitikei District Council and Horizons Regional Council to clear these drains. Landowners are responsible for drains that are classed as private.

### Picnic Table

N Eagland will check with the landowner (A Glasgow) about putting in a concrete slab for a picnic table to sit on. He had spoken to the work party in Feilding, who are happy to do the work. However, it was agreed that the Whanganui people be approached first; N Eagland will follow up.

### Turakina Tartan

S Welsh tabled the official colours. She had obtained two quotes to have the pattern printed on a 1mx2m board (including the names of the winning school students). It was agreed that she and D Wallen would go to the Caledonian Society's meeting to see if they are interested in funding this.

D Wallen will check out the Creative Communities Arts grant now open for applications via Rangitikei District Council.
