Ms Mauchline Campbell sought costs for painting the bus shelter. The Turakina tartan requires 7 colours and is likely to cost around \$130. Painting will occur after Christmas.

Ms Neilson is watering the plantings near the tables; shelters have been installed to protect them from the wind.

The seats are well used by both the local community and visitors. There is an increased number of people stopping, eating and taking photos of the community. Apart from the one incident, there has been little vandalism to the table.

The potential for a Facebook page to get messages out to the community was discussed.

SUBJECT: Small Projects Grant Scheme Update – February 2018

1 Allocation

- 1.1 The amount of the 2017-2018 Small Projects Grant Scheme for Turakina Ward is \$710.
- 1.2 The allocation of the Small Projects Grant Scheme is for the period 1 July to 30 June each year. At its meeting on 29 February 2016, Council resolved to allow carry-forward from one financial year to the next of up to 100% of the annual allocation for any Committee's Small Projects Grant Fund, with the proviso that this be a specific resolution of the Committee.
- 1.3 At its last meeting for the 2016-2017 year the Committee resolved to carry-over the balance of the Scheme; the remaining balance was \$260.00. This gives a total allocation for the 2017-2018 year of \$970.

2 Breakdown

- 2.1 For the 2017/2018 year the following amounts have been earmarked by the Committee (but unspent):
 - Up to \$200 Painting of the Bus shelter in Turakina Tartan.

3 Remaining Budget

• This leaves a remaining budget for the 2017-2018 financial year of \$770 (should the entire \$200 be spent).
