1 Allocation

- 1.1 The amount of the 2019-20 Small Projects Grant Scheme for Turakina Ward is \$710.
- 1.2 The allocation of the Small Projects Grant Scheme is for the period 1 July to 30 June each year. At its meeting on 29 February 2016, Council resolved to allow carry-forward from one financial year to the next of up to 100% of the annual allocation for any Committee's Small Projects Grant Fund, with the proviso that this be a specific resolution of the Committee.
- 1.3 At its last meeting for the 2018-2019 year the Committee resolved to carry-over 100% of the annual allocation of the Scheme; \$710. This gives a total allocation for the 2019-2020 year of \$1,420.00.

2 Breakdown

The following projects have been earmarked from the 2018/2019 year but unspent:

- \$400 for Painting of murals at Koitiata.
- \$500 to Turakina School towards the repair of the school slide.

Once an invoice has been received for the above earmarked projects, payment will then be made and the remaining budget updated.

Remaining Budget

- This leaves a remaining budget for the 2019-2020 financial year of \$1,420.00.

1 Executive Summary

Purpose of this report is to highlight inconsistency with property numbering for the township of Turakina and provide solutions for consideration.

- 1.1 The numbering system currently in place do not comply with the rural and urban addressing standard (Standards New Zealand / Australia, 2011) and numbers allocated to properties in Turakina Township are a cause of confusion which could have disastrous consequences when emergency services are required.
- 1.2 Three options proposed:
 - 1.2.1 First option proposed is for council to allocate and issue rapid numbers to properties on State Highway 3 through Turakina Township OR
 - 1.2.2 Option two: Undergo road name change for the section of road within township of Turakina, use the existing numbers OR
 - 1.2.3 Option three: Remain with status quo

2 Context / Background

Rangitikei District Council follows the rural and urban addressing standard (Standards New Zealand / Australia, 2011) which aims to keep addresses as simple as possible so that they can be easily understood by members of the public who are trying to find a property. This numbering system is implemented New Zealand wide.

The following rules apply with regards to numbering on highways crossing rural and urban areas as per the Rural and Urban Addressing standard (Standards New Zealand / Australia, 2011):

- 2.1 If the road name is the same for rural and urban sections of a highway, the rural numbering methods shall be applied throughout but varied as necessary in an urban area.
- 2.2 If one or more sections of a highway is assigned a separate name (such as in an urban area), numbering shall be in terms of the extent of that named road.

3 Current situation:

- 3.1 Rural numbers are assigned to properties **outside** the 70km/h area. Urban numbers are assigned to properties **within** Turakina Township.

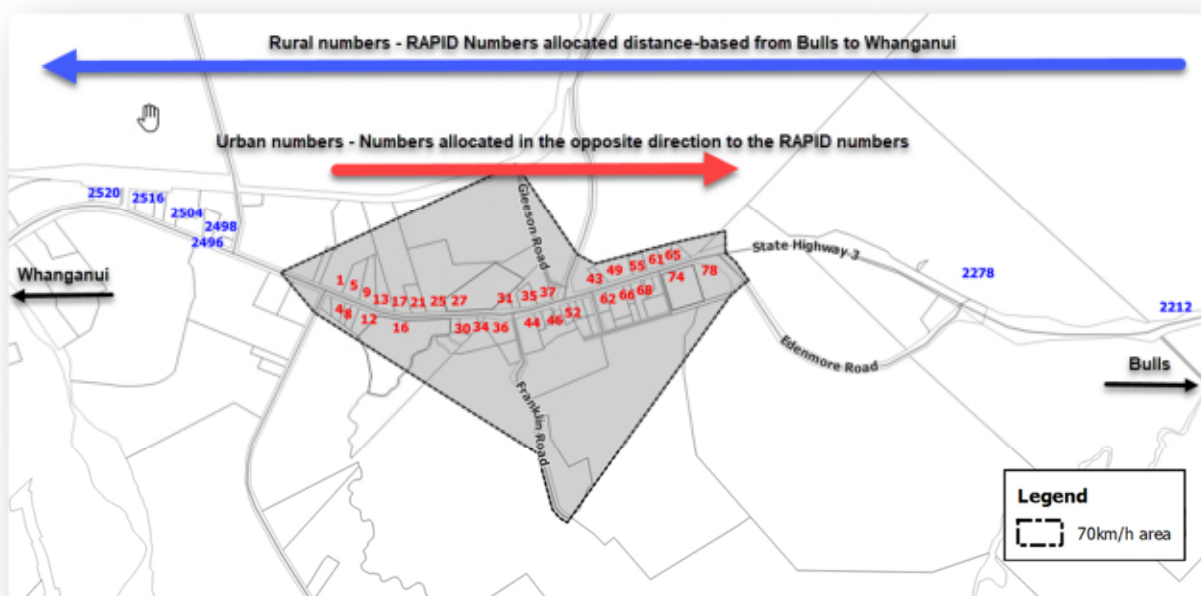


Figure 1: Turakina Township - Current numbering

- 3.2 State Highway 3 continues throughout the town and is not broken by a section of an urban road and the current numbering in place is in the opposite direction as the Rural numbers which could cause confusion (refer to Figure 1: Turakina Township - Current numbering below).

- 3.3 Majority of properties with access from State Highway 3 in the Turakina Township are not displaying the official allocated property number. Some properties are displaying a yellow plate with a four digit code which is likely to be an obsolete rural fire number

4 Conclusion

- 4.1 Numbering in Turakina Township is not aligned with the rural and urban addressing standard (AS/NZS 4819:2011).
- 4.2 Incorrect or confusing property numbering could have disastrous consequences when emergency services are required.
- 4.3 Numbering of properties are important in a national sense to ensure logical records for addressing of a road network.
- 4.4 Council has the statutory responsibility to issue a property number and road names within its district (Section 319(1)(j) and section 319B(1) Local government Act 1974).

5 Options:

- 5.1 **Option 1:** Council to allocate and issue rural distance-based numbers to properties on State Highway 3 through Turakina Township
- 5.2 **Option 2:** Undergo road name change for the section of road within township of Turakina, use the existing allocated numbers (note the numbers currently allocated are in the opposite direction to the rural numbers).
- 5.3 **Option 3:** Remain with status quo where existing allocated numbers are used. Letter to ratepayers to ensure that property owners display and maintain numbers allocated in the correct manner. All old / obsolete numbers to be removed

6 Costs

It is council policy to supply a RAPID number plate to properties where rural numbers have been allocated. Cost of green number stickers will cost approximately \$10 per property (approximately 43 properties). Council has previously purchased the blank metal RAPID number plates.

7 Recommendations

- 7.1 That the report 'Turakina Township SH3 Property Numbering' to the Turakina Community Committee be received.
- 7.2 The Turakina Community Committee recommends to Council that they allocate and issue rural distance-based numbers to Turakina township properties adjacent to State Highway 3 in line with Clause 5.9.1 of the Rural and Urban addressing standard (Standards New Zealand / Australia, 2011).

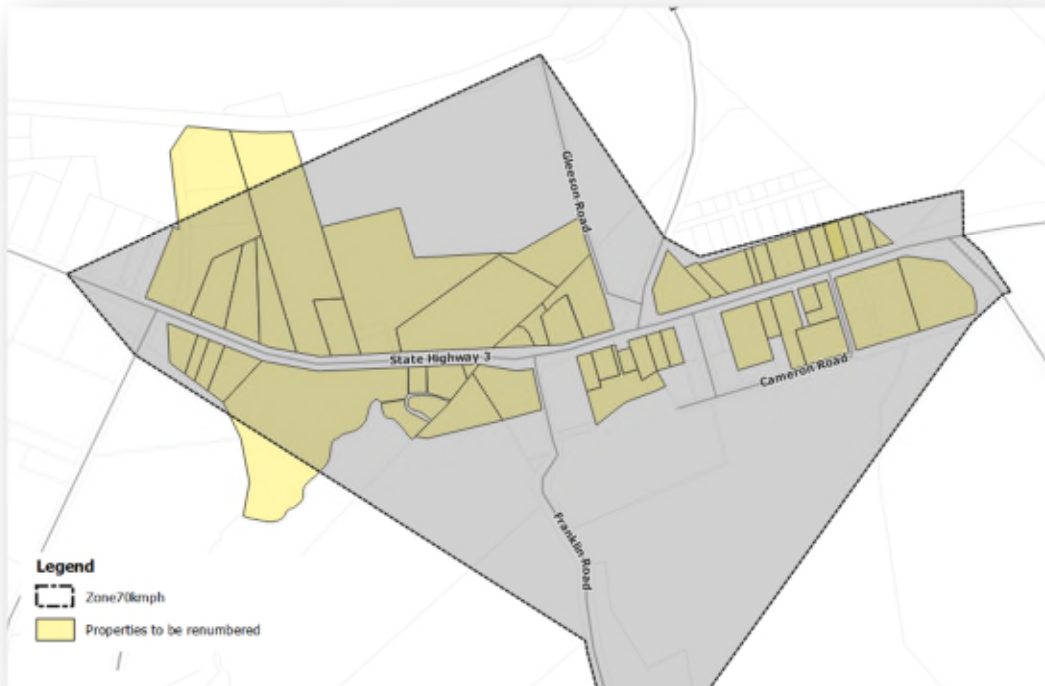


Figure 2: Properties in Turakina Township to be renumbered
