In relation to the Mayor and the Taihape Community Board, there is no election because the number of candidates standing for this election was not more than the number of vacancies.

This means Andy Watson, Ann Abernethy, Emma Abernethy, Michelle Fannin, and Gail Larsen are elected to their nominated positions unopposed.

As the remaining Wards and the Rātana Community Board have more candidates than positions there will be elections. Youth Council members will be able to contribute for the three ward 'meet the candidates evenings' as previously discussed. Noting that this could not be confirmed any earlier as staff were not sure as to the number of candidates standing.

Following this, and in discussion with the organising parties, namely Rotary Taihape, Lions Marton and Bulls Rural Women, the following dates will need to be calendared for Youth Council member contributions:

- September 20 Central Ward 'Meet the Candidates Evening' organised by Marton Lions. This event will be held at Rangitikei College.
- September 23 Northern Ward 'Meet the Candidates Evening' organised by Taihape Rotary Club. The location for this event has not been confirmed at present.
- September 26 Southern Ward 'Meet the Candidates Evening' organised by Bulls Rural Women. This event will be held at Bulls RSA.

Background

At its meeting held 23 July 2019 Rangitīkei Youth Council (RYC) agreed to investigate and establish the use of an online platform to engage with youth aged 12 to 24 across the Rangitīkei District. The purpose of the initiative is to garner a wider youth voice on topics and issues that affect or concern the youth community.

Wide Scope of Initiative

The RYC agreed to the following draft concept for further development:

- Facebook Messenger would be the most suitable platform.
- Participation would involve 50 youth aged 12 24.
- Feedback sought would include Central and Local Government consultation, RYC initiated conversations on life, health, community and the potential for specific agency questions.
- Data collected would be used to effect change through submissions to Council,
 Central Government along with agencies, educators and businesses.

Current Position

RYC member Makayla Vaa is lead for this project and has formulated the draft Participation Rules <u>Appendix 1</u> and draft Elevator Pitch for secondary schools <u>Appendix 2</u>. Ms Vaa has approached Rangitīkei College principal, Tony Booker, who is engaging with 10 potential students to participate.

The suggested breakdown of youth participating is as follows:

10 members from each of the three district high schools, 2 from each year level	30
10 from out of district schools	10
10 in the age bracket 18-24	10
TOTAL	50

Considerations

Rangitīkei District Council have to consider the potential risks to community and the organisation within any project. There are inherent risks when engaging with any community group on matters that could concern them on a personal or emotional level, with a reasonable level of care, moderation and risk management needing to be implemented. Council are currently working with external agencies to formulate an appropriate risk management and support network to sit alongside Voice Box. This will need to be established prior to launching Voice Box and explained to each participant and caregiver (if the participant is under 18 years of age) as part of the induction and participation agreement.

Recommendations:

- That the memorandum 'Voice Box District Youth Voice' to the 20 August 2019 Rangitīkei Youth Council meeting be received.
- That the Rangitikei Youth Council [agree/do not agree] to the Participation Rules as [amended/without amendment] at the 20 August 2019 meeting.
- That the Rangitīkei Youth Council [agree/do not agree] to the Elevator Pitch as [amended/without amendment] at the 20 August 2019 meeting.

THE RANGITIKEI YOUTH VOICE

Rangitīkei Youth Council is creating an online communication platform called 'Voice Box' to capture youth Voice, Ideas and Solutions on topics that affect Rangitīkei Youth.

Feedback from a cross-section of 50 youth aged 12-24 will influence agencies, stakeholders and change makers to make meaningful impact.

We are seeking 2 students from each year level that know the value of their voice and ideas, that will be active participants, open minded, respectful and solution focused.

Feedback sought will be on a range of topics from government and council consultation, lifestyle, town facilities, health, agency specific questions and more.

Feedback will require insightful reflection and for some may be trigger topics. For this reason, participation in Voice Box will require a signed agreement and caregiver permission (for youth aged under18) supplied by Rangitīkei District Council.

Participating youth will gain the experience of having their ideas solicited, their voice listened to and knowing that their ideas matter.

Youth are not the future of tomorrow, they are our future today.
